



EXECUTIVE ORDER NO. 08

**AN ORDER DECLARING THE LOCALIZED SUSPENSION OF  
WORK IN GOVERNMENT OFFICES AND CLASSES IN  
PUBLIC SCHOOLS IN THE MUNICIPALITY OF  
CONCEPCION, TARLAC ON FEBRUARY 25, 2025,  
IN COMMEMORATION OF THE EDSA PEOPLE POWER  
REVOLUTION**

**WHEREAS**, Proclamation No. 727, s. 2024, issued by the President Ferdinand R. Marcos Jr., declares February 25, 2025, as a special working holiday in observance of the EDSA People Power Revolution Anniversary;

**WHEREAS**, the Municipal Government of Concepcion, Tarlac acknowledges and honors the profound historical significance of the February 25, 1986, EDSA People Power Revolution, which played a pivotal role in shaping and safeguarding our democracy;

**WHEREAS**, in commemoration of this milestone, the Municipal Government of Concepcion, Tarlac deems it relevant to declare the suspension of work in government offices under its jurisdiction, and public schools within Concepcion, Tarlac, to provide our constituents with the opportunity to reflect on the historical importance of EDSA People Power Revolution, and to honor the values of unity, democracy, and freedom that it represents;

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the Municipal Mayor the authority to ensure and support the preservation and enrichment of culture and history, promote general welfare, and, when necessary, declare localized suspensions of work and classes for justifiable reasons;

**NOW, THEREFORE, I, NOEL L. VILLANUEVA**, Municipal Mayor of Concepcion, Tarlac, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. DECLARATION OF SUSPENSION.**

Work in all municipal government offices and classes in all public schools (elementary and secondary) within the Municipality of Concepcion, Tarlac, are hereby suspended on February 25, 2025. This suspension shall not extend to private institutions, businesses, and national government offices/agencies unless they voluntarily opt to observe the suspension of work/classes at their discretion.

**SECTION 2. SCOPE AND COVERAGE.**

This Executive Order applies to:

- a. All offices under the Municipal Government of Concepcion, Tarlac.
- b. All public schools within the jurisdiction of Concepcion, Tarlac, in coordination with the Department of Education (DepEd) Concepcion District.

**SECTION 3. EXEMPTIONS.**

To ensure the continuity of essential public services during the suspension period, the following offices shall remain operational through their assigned personnel/skeletal force:

- a. Municipal Disaster Risk Reduction and Management Office (MDRRMO);
- b. Municipal Health Office (MHO) and Rural Health Units (RHUs);
- c. Other offices and personnel involved in traffic management, emergency response, public safety, health services, and essential public services.

**SECTION 4. DUTIES AND RESPONSIBILITIES.**

- a. Heads of Offices shall ensure the proper dissemination of this Executive Order to all employees under their supervision.
- b. The Offices under Section 3 of this Order, through their assigned personnel/skeletal force shall remain operational to address emergencies and maintain public safety during the suspension period.
- c. The DepEd Concepcion District shall coordinate with public school principals to inform students, parents, and guardians of the suspension of classes.
- d. The Municipal Government of Concepcion shall publish this Executive Order through official communication channels, including the municipality's social media pages.

**SECTION 5. SEPARABILITY CLAUSE.**

Should any provision of this Executive Order be declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.


**SECTION 6. REPEALING CLAUSE.**

All orders, rules, and regulations, or parts thereof, that are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION 7. EFFECTIVITY.**

This Executive Order shall take effect immediately upon its issuance and shall remain in force only for February 25, 2025.
