**RECONSTITUTION OF THE MUNICIPAL YOUTH
DEVELOPMENT COUNCIL OF CONCEPCION, TARLAC,
AND DESIGNATION OF ITS FUNCTIONS
AND FOR OTHER PURPOSES**

WHEREAS, Article 2 Section 13 of the 1987 Constitution provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth patriotism and nationalism and encourages their involvement in public and civic affairs;

WHEREAS, Section 23, Chapter III of Republic Act No. 10742 or the Sangguniang Kabataan Reform Act of 2015, mandates the creation in every province, city, and municipality a Local Youth Development Council (LYDC) to ensure wide and multi-sectoral youth participation in local governance. The LYDC shall be composed of representatives of youth and youth-serving organizations in the provincial, city, and municipal level;

WHEREAS, Section 24(i), Rule III of the Implementing Rules and Regulations of Republic Act 10742 states that the LYDC shall be composed of at least (10) but not more than twenty-one (21) members including the two (2) core members from the Sangguniang Kabataan. The two (2) core members shall be composed of the president and the vice-president of the concerned Pederasyon and shall be supported by at least five (5) but not more than nineteen (19) other representatives from registered youth organizations or youth-serving organizations, provided that all other incumbent SK officials shall not be eligible as a member of the LYDC;

WHEREAS, the youth council shall serve as the main advocate for youth participation in nation-building and youth empowerment, monitoring and implementation of programs and projects under the Local Youth Development Plan;

WHEREAS, it is a declared policy of the local government to promote and protect the physical, moral, spiritual, intellectual, cultural, and social well-being of the youth and to inculcate in them values of patriotism and nationalism and to encourage their involvement in public and civic affairs of the city;

WHEREAS, in compliance with Republic Act No. 10742 or the Sangguniang Kabataan Reform Act of 2015, the Municipality of Concepcion, Tarlac constituted its Municipal Youth Development Council (MYDC) to ensure that its youth are given priority, and that programs, plans and actions will be truly beneficial to them;

WHEREAS, there is a need to reconstitute the MYDC for full promotion and protection of the physical, moral, spiritual, intellectual, cultural and general welfare of the youth through the representation of various youth/youth serving organizations within the Municipality;

NOW, THEREFORE, I, NOEL L. VILLANUEVA, Municipal Mayor, by virtue of the powers vested in me by law, do hereby reconstitute the Municipal Youth Development Council of Concepcion, Tarlac, and designates its functions, and for other purposes, to wit:

SECTION 2. FUNCTIONS.

1. Serve as the core of the advocacy on youth participation in nation-building and youth empowerment;
2. Finalize the three (3) year LYPD that is anchored in the PYDP and the development plans of the local government units which will give priority to program, projects and activities that will promote and ensure the meaningful youth participation in nation-building, sustainable youth development and empowerment, equitable access to quality education, environmental protection, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health and anti-drug abuse, gender sensitivity, social protection, capability building and sports development;
3. Monitor and evaluate the implementation of the Local Youth Development Plan; and
4. Assist in the planning and execution of projects and programs of the Sangguniang Kabataan, and the Pederasyons in all levels.
5. Perform such other functions as may be prescribed by law or ordinance

SECTION 3. MEETINGS AND QUORUMS

The MYDC shall schedule a meeting every quarter, and as often as needed. The presence of the majority of all members of the MYDC shall constitute a quorum.


SECTION 5. REPEALING CLAUSE
