**AMENDMENT TO EXECUTIVE ORDER NO. 72,  
SERIES OF 2024 ENTITLED “STRENGTHENING  
TOBACCO AND VAPE CONTROL MEASURES IN THE  
MUNICIPALITY OF CONCEPCION, TARLAC,  
AND ESTABLISHING THE MUNICIPAL TOBACCO  
CONTROL TASK FORCE” AS TO THE  
COMPOSITION OF THE MUNICIPAL TOBACCO  
CONTROL TASK FORCE**

**WHEREAS**, Republic Act (R.A.) No. 9211, or the Tobacco Regulation Act of 2003, and Executive Order (E.O.) No. 26, Series of 2016, mandate the establishment of smoke-free environments in public and enclosed places;

**WHEREAS**, the Municipality of Concepcion, Tarlac recognizes the need to adopt local-level mechanisms to protect the public, especially minors, from the harmful effects of tobacco use, vaping, and exposure to second-hand smoke;

**WHEREAS**, the Municipal Government of Concepcion, Tarlac duly issued Executive Order No.72, Series of 2024 entitled “Strengthening Tobacco and Vape Control Measures in the Municipality of Concepcion, Tarlac, and Establishing the Municipal Tobacco Control Task Force”;

**WHEREAS**, members of the Municipal Tobacco Control Task Force were designated in the said Executive Order to enforce the provisions of E.O. No. 72, Series of 2024 and monitor compliance thereto;

**WHEREAS**, there is a need to reorganize the Municipal Tobacco Control Task Force as some members are not incumbent anymore due to the local elections for the term 2025-2028;

**NOW, THEREFORE, I, NOEL L. VILLANUEVA**, Municipal Mayor of Concepcion, Tarlac, by virtue of the powers vested in me by law, do hereby order the reorganization of the Municipal Tobacco Control Task Force (MTCTF), to be composed of the following:
