**REORGANIZATION OF THE LOCAL HEALTH BOARD OF
THE MUNICIPALITY OF CONCEPCION, TARLAC**

WHEREAS, the implementation of the Local Government Code of 1991 resulted in the devolution of health services from the National Government to local government units (LGUs) which included among others, the provision, management and maintenance of health services at different levels of LGUs;

WHEREAS, Section 102, Title V of the Local Government Code of 1991, and Article 185 of the Implementing Rules and Regulations of the same Code mandate the creation of a Local Health Board in every province, city or municipality;

WHEREAS, the Local Health Board is mandated to perform the functions enumerated in Section 102 (3)(b) of the Local Government Code of 1991;

WHEREAS, locally elected officials can make a major contribution to the health of citizens by making decisions that incorporate healthy community characteristics into their official community plans, policies and infrastructure;

WHEREAS, with the newly elected local government officials of the Municipality of Concepcion, Tarlac for the term 2025-2028, and the designation of new personnel within the agencies concerned, there is a need to reorganize the Local Health Board of the Municipality of Concepcion, Tarlac (Municipal Local Health Board) which resulted to the identification of a new set of members/representatives to constitute it;

NOW THEREFORE, I, NOEL L. VILLANUEVA, Municipal Mayor, by virtue of the power vested in me by the law, do hereby reorganize the Local Health Board of the Municipality of Concepcion, Tarlac (Municipal Local Health Board), to wit:

SECTION 1: COMPOSITION

The Municipal Local Health Board shall be composed of the following individuals:

SECTION 2. FUNCTIONS

The Municipal Local Health Board shall have the following functions:

1. Propose to the Sanggunian concerned, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality, city or province, as the case may be;
2. Serve as an advisory committee to the Sanggunian concerned on health matters such as, but not limited to, the necessity for, and application of, local appropriations for public health purposes; and
3. Consistent with the technical and administrative standards of the Department of Health, create committees which shall advise local health agencies on matters such as, but not limited to personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations review and similar functions.

SECTION 3. MEETINGS AND QUORUM

The Municipal Local Health Board shall meet at least once a month or as often as may be necessary. A majority of its members shall constitute a quorum, but the Chairman and Vice Chairman must be present during the meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.

SECTION 4. COMPENSATION AND REMUNERATION

The Chairman, Vice Chairman and Members of the Municipal Local Health Board shall perform their duties as such without compensation or remuneration, except those who are not government officials or employees who shall be entitled to necessary travelling expenses and allowances

chargeable against the funds of the Municipal Local Health Board, subject to existing accounting and auditing rules and regulations.


SECTION 5. DIRECT NATIONAL SUPERVISION AND CONTROL BY THE SECRETARY OF HEALTH

The Municipal Local Health Board shall adhere to Sec. 105 of the Local Government Code of 1991, that, in cases of epidemics, pestilence, and other widespread public health dangers in the Municipality of Concepcion, Tarlac, the Secretary of Health may, upon the direction of the President and in consultation therewith, temporarily assume direct supervision and control over the said Municipality's health operations for the duration of the emergency for a cumulative period not exceeding six (6) months, but which may be extended with the concurrence of the Municipality.

SECTION 6. EFFECTIVITY

This Executive Order shall take effect immediately, and revoke or amend accordingly all orders, issuances or memorandum which are inconsistent herewith.
