**REORGANIZATION OF THE LOCAL HEALTH PLANNING TEAM
OF THE MUNICIPALITY OF CONCEPCION**

WHEREAS, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Local Government Code mandates local government units (LGUs) to ensure the delivery of basic health services to their constituents through effective planning and implementation;

WHEREAS, the Municipality of Concepcion, Tarlac aims to strengthen its capacity to develop and implement strategic health plans that address the evolving health needs of the community;

WHEREAS, the establishment of a Local Health Planning Team (LHPT) is essential for conducting comprehensive health assessments, developing responsive health policies, and strategically planning for health service delivery;

WHEREAS, a Local Health Planning Team (LHPT) will facilitate the planning, coordination, and implementation of health programs and services in the Municipality of Concepcion, Tarlac;

WHEREAS, the Municipal Government of Concepcion, Tarlac duly issued Executive Order No.65, Series of 2024 creating the Local Health Planning Team of the Municipality of Concepcion;

WHEREAS, in light of the recent 2025 elections, there is a need for a reorganization of the Local Health Planning Team of the Municipality of Concepcion to reflect its new members;

NOW, THEREFORE, I, NOEL L. VILLANUEVA, Mayor of the Municipality of Concepcion, Tarlac, by the powers vested in me by law, do hereby order, to wit:

SECTION 1. COMPOSITION. The Local Health Planning Team shall consist of the following members:

SECTION 2. FUNCTIONS AND RESPONSIBILITIES. The Local Health Planning Team shall have the following functions and responsibilities:

1. Conduct a comprehensive health assessment to identify the health needs and priorities of the community.
2. Develop and recommend health policies, strategies, and programs based on the health assessment findings.
3. Prepare the Municipal Health Plan, ensuring alignment with national health priorities and local resources.
4. Facilitate stakeholder consultations and partnerships to promote collaborative health planning.
5. Monitor and evaluate the implementation of health programs and make necessary adjustments.
6. Provide regular reports and updates to the Mayor and the Sangguniang Bayan regarding health planning activities.


SECTION 3. MEETINGS. The Local Health Planning Team shall convene regularly, at least quarterly, and may call for special meetings as deemed necessary to perform its functions and fulfill its responsibilities.

SECTION 4. FUNDING. Funds for the Local Health Planning Team's administrative, logistical, and operational needs may be sourced out from the available funds of the Municipal Health Office or local general funds, subject to mandated government auditing rules.

SECTION 5. REPEALING CLAUSE. This Executive Order repeals or amends accordingly any executive order or issuance which is inconsistent herewith.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately.
