**REORGANIZATION OF THE
PEOPLE'S LAW ENFORCEMENT BOARD (PLEB)
OF THE MUNICIPALITY OF CONCEPCION, TARLAC**

WHEREAS, Republic Act No. 8551 otherwise known as the "Philippine National Police Reform and Reorganization Act of 1998" (which amended Republic Act No. 6975 or the DILG Act of 1990), established the People's Law Enforcement Board (PLEB) in every municipality/city;

WHEREAS, the PLEB is a check and balance mechanism created by law against erring policemen as it was designated to be the central receiving entity for any citizen's complaints against officers and members of the Philippine National Police (PNP).

WHEREAS, there is a need to reorganize the People's Law Enforcement Board (PLEB) of the Municipality of Concepcion, Tarlac to comply with the set of rules on the appointment of PLEB members and to ensure that all key sectors of the Municipality are duly represented in the Board;

WHEREAS, pursuant to RA 8551, the PLEB shall be composed of the following;

1. One (1) Sangguniang Bayan representative;
2. One (1) representative from the Liga ng mga Barangay;
3. Three (3) individuals from the community known for their probity and integrity, one (1) of whom must be a woman, a member of the Bar, or, in the absence thereof, a college graduate, and principal of the central elementary school in the locality;

The Chairman must be selected from among the members.

NOW, THEREFORE, I, **HON. NOEL L. VILLANUEVA**, Municipal Mayor of Concepcion, Tarlac, by virtue of the powers vested in me by law, do hereby order, to wit:

SECTION I. COMPOSITION.

SECTION 2. DUTIES AND RESPONSIBILITIES.

Section 9 of the NAPOLCOM Manual of Procedure for the People's Law Enforcement Boards provides that the PLEB shall have the power to hear and adjudicate all administrative complaints formally filed with, or referred to it against any member of the PNP and to impose the corresponding penalty. In the exercise of its functions, the PLEB, acting through its Chairman, is empowered to administer oaths, summon witnesses, require the production of documents, records, books, or other things by a subpoena duces tecum and issue other processes as maybe necessary. Applying the provisions of Article 152, Chapter IV, Title III, Book II of the Revised Penal Code, the members of the PLEB are considered as persons-in- authority.

SECTION 3. REPEALING CLAUSE.


All Orders or issuances which are inconsistent herewith shall be deemed revoked, superseded or amended accordingly by this Executive Order.

SECTION 4. EFFECTIVITY

This Executive Order shall take effect immediately.
